REGULAR MEETING

JANUARY 27, 2020

Mayor Shaner called the Regular Meeting of the Hampton Borough Council to order at 7:30p.m. Mayor. Shaner gave the Open Public Meetings Act Statement. . This meeting was held in compliance with the Open Public Meetings Act. The Annual Notice was adopted on January 6, 2020 and was published in the Hunterdon Democrat on January 09, 2020. Comments and Questions from the Public:

Marci Krasny, Business Administrator and Jason Kornegay, Superintendent of the Hampton Public School noted that they are in attendance to see if the Borough Council would consider entering into a shared services agreement for services such as lawn mowing and snow removal. Several years ago there was a shared services agreement.

Mayor Shaner requested that the Borough Council have an opportunity to take a look at the request and get back to Ms. Krasny and Mr. Kornegay, they were fine with this request.

Cm Rega will be meeting with Mr. Kornegay and Ms. Krasny to work on an agreement.

Jose Medeiro, Bethlehem Township Committeeman – inquired as to whether the Borough Council has ever considered using Green Acres or County Open Space funds to buy out the developer that is looking to build the development on Valley Road. Mr. Medeiro noted that he is willing to help with the process if the Borough Council is interested in pursuing this option.

Fire Chief, Rick Allen brought handed out a packet of information to the members of the Borough Council that contained budgetary information for review by the Borough Council. Fire Chief Allen reviewed the document with the members present. Chief Allen noted that the Fire Company is not expecting answers tonight but wanted the Borough Council to know what the Fire Company feels that it needs to provide fire services to the Borough and to keep the members safe when responding to calls.

Communications:

Request from the Hampton Woman's Club to be on the Agenda to share the artist renderings for the Welcome to Hampton signs. Mrs. Cregar was in attendance to show the Borough Council the renderings

of the "Welcome to Hampton" signs that the Woman's Club is donating to the Borough. Mrs. Cregar showed the current signs and the new design for the signs. Once the signs are in place they become property of the Borough, they will need to be added to the Fixed Asset list and insured.

Mrs. Cregar also noted that the Hampton Woman's Club will be dissolving due to lack of membership, the signs are the last project for the club and then they will then be out of money. The Woman's Club will do the egg hunt in April and that will be it.

Memo from Town of Clinton requesting Hampton Borough to pass a similar Resolution passed by them supporting securing a grant to convert Hunterdon County Polytech into a full time career and technical school. The member of the Borough Council all agreed that a Resolution should be done, Borough Clerk Leidner will prepare and have it ready for the next meeting.

Letter to Highlands's Council re: Water Use and Conservation Management Plan. All members of the Borough Council approved the letter as presented by Borough Attorney Tar St. Angelo, the Borough Clerk will let her know of the approval.

Alan Brower reported on the progress of the well project. The DEP will come out and do inspections. After the inspections a series of water testing need to be done before the well goes online. Having Well #5 up and running should be fairly quick so that work on Well #4 can get started.

Cm. Rega reported that things are moving forward on the crossing guard situation, this will be discussed in Executive Session.

Cm. Wotanowski reported that he has been working with William Fleck on getting his Eagle Scout proposal ready.

Cm. Drummond – reported that the Borough Engineer has been working on the layout and planning for the Main Street improvements. Mr. Brower noted that letters should be sent to the gas company and residents to let them know if they want to tie into the gas line this needs to be done prior to the construction.

Cm. Baker reported that we are currently waiting for approval from the AOC for the Court transfer.
