APPROVAL OF MINUTES:

Communications:

Letter from a resident requesting the Borough Council authorize the assignment of liens of a property located behind their property.

This property has a municipal lien. Borough Attorney noted that the Statute allows for assignment if the requestor is willing to pay for the outstanding liens. However, there needs to be further research done by the Assessor before any decisions can be made regarding this request.

Cm. Rega – has been approached by the Hampton School Board to revisit the Shared Services Agreement between Hampton Borough and Hampton School. Mr. Rega, Mr. Tampier and Alan will review the past Shared Services Agreement and then meet with Hampton School. Borough Clerk

Leidner was asked to locate the Shared Services Agreement and send o Mr. Rega, Mr. Tampier and Mr. Brower.

Cm. Tampier inquired as to whether South Branch could be allowed to put out more than one can of garbage per week. DPW Director Brower did not feel comfortable making that decision without Council approval. All members present agreed that the squad should be allowed 64 gallons (2 cans) per week. The Garbage Ordinance will need to be modified to reflect this change. Mr. Brower and Borough Clerk Leidner will review the Ordinance and make recommendations to the Borough Attorney. It was also discussed that the Fire Company Hall rental use of dumpster should be addressed and a fee charged.

MUNICIPAL CLERK'S REPORT:

Borough Clerk Leidner noted that Water bills have been mailed and the new billing system is very user friendly. She also reported that the rabies clinic went well and 85 animals were vaccinated.

RESOLUTION NO. 32-2023

STATEWIDE INSURANCE FUND

RESOLUTION TO JOIN (RENEW) THE FUND

WHEREAS, a number of local units have joined together to form the Statewide Insurance Fund ("FUND"), a joint insurance fund, as permitted by N.J.S.A. 40A:10-36, et seq.; and

WHEREAS , Borough of Hampton ("LOCAL UNIT") has complied with relevant law with regard to the acquisition of insurance; and

WHEREAS, the statutes and regulations governing the creation and operation of joint insurance funds contain elaborate restrictions and safeguards concerning the safe and efficient administration of such funds; and

WHEREAS, the LOCAL UNIT has determined that membership in the FUND is in the best interest of the LOCAL UNIT.

WHEREAS, the LOCAL UNIT agrees to be a member of the FUND for a period of three (3) years, effective from January 1, 2023 terminating on January 1, 2026 at 12:01 a.m. standard time; and

WHEREAS, the LOCAL UNIT has never defaulted on claims, if self-insured, and has not been canceled for non-payment of insurance premiums for two (2) years prior to the date of this Resolution.

NOW, THEREFORE, BE IT RESOLVED that the LOCAL UNIT does hereby agree to join the Statewide Insurance Fund; and

BE IT FURTHER RESOLVED that to the extent required by law, the Local Unit shall provide notice of the Indemnity and Trust Agreement to the Office of the State Comptroller; and

BE IT FURTHER RESOLVED that the LOCAL UNIT will be afforded the following coverage(s) as marked "Yes":

BE IT FURTHER RESOLVED that the LOCAL UNIT's Fund Commissioner is authorized and directed to execute the Indemnity and Trust Agreement and such other documents signifying the membership in the FUND as required by the FUND's Bylaws and to deliver same to the Administrator of the FUND with the express reservation that said documents shall become effective only upon the LOCAL UNIT's admissions to the FUND following approval of the FUND by the New Jersey Department of Banking and Insurance.
